## TERMS AND CONDITIONS

1. MEMBERSHIP IS OPEN TO EVERYONE BETWEEN THE AGES OF 18 YEARS AND 74 YEARS.
2. NON REFUNDABLE MEMBERSHIP FEE IS R150.00 PER PERSON PER MONTH. MEMBERSHIP FEE FOR PERSONS ABOVE 64 YEARS IS R190.00 PER MONTH. MEMBERSHIP FEE IS TO BE PAID FROM THE MONTH OF DECEMBER 2024. MEMBERSHIP FEE SHOULD BE PAID BY THE 7TH OF EACH MONTH.
3. ENTREPRENEURS WILL FORFEIT THEIR MONTHLY PAYMENTS SHOULD MONTHLY INSTALLMENTS BE NOT HONoured.
4. MEMBERSHIP NUMBER WILL BE ISSUED UPON RECEIVING THE APPLICATION FORM AND THE INITIAL MEMBERSHIP FEE. THE ENTREPRENEUR WILL BE PLACED ON THE WAITING LIST FOR STOCK OR FOR CONTAINER OR FOR TUCKSHOP REBRANDING. MEMBERSHIP CERTIFICATE WILL BE ISSUED ONCE THE MEMBERSHIP FEE HAS BEEN PAID.
5. MEMBERS WILL ONLY QUALIFY FOR STOCK OR CONTAINER ONCE THE FULL MEMBERSHIP FEE HAS BEEN PAID. MEMBERS WHO JOIN AFTER THE MONTH OF DECEMBER 2024 SHOULD PAY ALL MONTHLY FEE AS FROM DECEMBER 2024.
6. MEMBERS ARE REQUIRED TO PUT THEIR CELLPHONE NUMBERS AS A REFERENCE NUMBER WHEN REGISTERING AND MAKING MONTHLY PAYMENTS.
7. FAILURE TO MAKE THE MONTHLY CONTRIBUTION WILL RESULT IN PENALTIES. MEMBERS MAY HAVE A TWO-MONTH GRACE PERIOD TO SKIP PAYMENTS WITHOUT PENALTY; SUCH MEMBER MUST HOWEVER MAKE A WRITTEN APPLICATION TO THE BOARD OF DIRECTORS FOR PERMISSION TO SKIP MONTHLY FEE.
8. A MEMBER MAY NOT APPLY FOR TWO GRACE PERIODS IN ONE CALENDAR YEAR. FROM THE THIRD MONTH ONWARDS, MEMBERS WILL BE LIABLE TO PAY THE OUTSTANDING AMOUNT PLUS 10% INTEREST ON ALL OUTSTANDING AMOUNTS. SHOULD A MEMBER FAIL TO MAKE MONTHLY CONTRIBUTION ON MONTH FOUR THEN MEMBERSHIP MAY/WILL BE FORFEITED.
9. THE MONTHLY MEMBERSHIP FEE WILL AUTOMATICALLY ENABLE AGCTA MEMBERS TO QUALIFY FOR A MALI YAMI FUNERAL CASH COVER OF R10 000.00. THE FUNERAL COVER WILL COME INTO EFFECT ON THE 3RD MONTH OF REGISTERING WITH AGCTA AND PAYING THE MONTHLY FEE OF R150.00.
10. APPLICATION FORMS OF THE FUNERAL COVER ARE ATTACHED IN ANNEXURE A. MEMBERS MUST READ THE TERMS AND CONDITIONS OF THE FUNERAL COVER AND SIGN THE MALI YAMI FUNERAL COVER APPLICATION FORM.
11. ONCE MEMBERS LOOSE THEIR MEMBERSHIP, SERVICES AND BENEFITS PROVIDED BY AGCTA WILL BE TERMINATED. THE FUNERAL COVER WILL ALSO BE TERMINATED. MEMBERS WILL NEED TO START A NEW APPLICATION.
12. MEMBERS SHOULD HAVE COMMON GOALS AND OBJECTIVES AS TO THAT OF AGCTA.
13. MEMBERS ARE REQUIRED TO ATTEND ONLINE MEETINGS MONTHLY.
14. MEMBERS MUST ACTIVELY PARTICIPATE IN THE DEVELOPMENT AND GROWTH OF THE ASSOCIATION; THIS INCLUDES MOBILIZING FOR NEW MEMBERS AND OR CUSTOMERS FOR PRODUCTS AND ITS SERVICES.
15. BENEFICIARIES - MEMBERS MAY NOMINATE THEIR OWN BENEFICIARIES WHO WILL BE ABLE TO CONTINUE WITH THEIR MEMBERSHIP IN THE EVENT THE MEMBER BECOMES INCAPACITATED OR PASSES ON. BENEFICIARIES MAY ALSO SERVE ON THE COMMITTEES AS WELL AS ON THE ASSOCIATION STRUCTURES ON BEHALF OF THE MEMBERS.
16. MEETINGS - MEETINGS ARE MANDATORY FOR ALL MEMBERS. MEETINGS WILL BE HOSTED VIRTUALLY FOR MEMBERS IN REMOTE AREAS. IF A MEMBER CANNOT MAKE IT TO A MEETING, THE INDIVIDUAL SHOULD NOTIFY THE ORGANIZATION IN TIME EITHER VIA WHATSAPP OR TELEPHONE CALL. IF A MEMBER FAILS TO ATTEND 3 CONSECUTIVE MEETINGS WITHOUT FORMAL WRITTEN EXCUSE AND/OR NOTIFICATION; THEN MEMBERSHIP WILL/MAY BE TERMINATED UPON THE DECISION OF THE DISCIPLINARY COMMITTEE AND/OR THE BOARD.
17. MEMBERS MUST PLACE ORDERS FOR TUCKSHOP STOCK/PRODUCTS THROUGH THE AGCTA AS LONG AS THEY ARE MEMBERS OF THE ASSOCIATION. MEMBERS ARE EXPECTED TO PLACE THEIR ORDERS WEEKLY AND/ OR MONTHLY. MEMBERS ARE EXPECTED TO PLACE ORDERS FOR NEW STOCK 4-6 WEEKS AFTER GETTING THEIR START UP STOCK AD OR CONTAINER.
18. MEMBERS MUST OPEN MALI YAMI BUSINESS BANK ACCOUNTS IN ORDER TO BENEFIT FROM THE ASSOCIATION AND IN ORDER TO GET FINANCIAL ASSISTANCE THROUGH THE ASSOCIATION'S STAKEHOLDERS.
19. MEMBERS MUST ALLOW AGCTA BRANDING ON THEIR TUCKSHOP BOTH ON AND OFF BUSINESS PREMISES.


## TERMS AND CONDITIONS

20. MEMBERS MUST SIGN AN NDA WITH THE ASSOCIATION TO ENSURE THAT TRADE SECRETS, BUSINESS MODELS, METHODS, PATENTS, TRADEMARKS, STAKEHOLDERS, AND ETC ARE PROTECTED AT ALL TIMES.

21. MEMBERS ARE REQUIRED TO ENTER INTO A MEMBERSHIP CONTRACT AGREEMENT WITH AGCTA. THE CONTRACT AGREEMENT IS BINDING FOR A PERIOD OF 5 YEARS (60 MONTHS). THE ENTREPRENEUR / TUCKSHOP OWNER IS ALLOWED TO CONTINUE WITH THE AGCTA MEMBERSHIP BEYOND THE 5 YEAR PERIOD SHOULD THEY WISH TO. THE CONTRACT AGREEMENT SHALL BE TERMINATED UPON A ONE MONTH WRITTEN NOTICE.

22. MEMBERS WHO SIGN UP FOR THE AGCTA MEMBERSHIP ARE AUTOMATICALLY ENTERING INTO A JOINT VENTURE AGREEMENT BETWEEN AGCTA AND THEMSELVES. A SEPERATE JOINT VENTURE AGREEMENT WILL BE SIGNED BY BOTH ENTITIES.

## **1. PURPOSE**

THE PURPOSE OF THIS AGREEMENT IS TO OUTLINE THE TERMS AND CONDITIONS UNDER WHICH THE MEMBER WILL RECEIVE STOCK / CONTAINER / REBRANDING AND CONTRIBUTE TO THE ORGANIZATION'S GOALS OF SUPPORTING TUCKSHOP OPERATIONS.

## **2. MEMBERSHIP FEE**

THE MEMBER AGREES TO PAY A MONTHLY NON REFUNDABLE MEMBERSHIP FEE OF R150, WHICH GRANTS ELIGIBILITY TO RECEIVE STOCK VALUED AT R10000 AND/OR ACCESS TO FUNDING TO PURCHASE A CONTAINER, AND / OR ACCESS TO FUNDING TO REVAMP/REBRAND AN EXISTING STRUCTURE. MEMBERS ABOVE 64 AGREE TO PAY MONTHLY MEMBERSHIP OF R190.00. MEMBERSHIP FEE IS PAYABLE AS FROM DECEMBER 2024, MEMBERS THAT JOIN THE ASSOCIATION AFTER THE MONTH OF DECEMBER 2024 WILL HAVE TO CATCH UP WITH THEIR MONTHLY PAYMENTS UNTIL ALL OUTSTANDING AMOUNTS ARE SETTLED.

## **3. DUE DILIGENCE PROCESS**

BEFORE RECEIVING STOCK, THE ORGANIZATION WILL CONDUCT A DUE DILIGENCE ASSESSMENT TO EVALUATE:

- MEMBER READINESS TO RECEIVE STOCK
- MEMBERS COMPLIANCE DOCUMENTS
- MEMBERS WHO ALREADY OWN TUCK SHOPS
- THE LOCATION FOR NEW TUCK SHOPS BEING SET UP BY MEMBERS WITHOUT EXISTING OPERATIONS.

THE MEMBER AGREES TO COOPERATE FULLY WITH THIS ASSESSMENT.

## **4. TRAINING REQUIREMENT**

THE MEMBER MUST COMPLETE A MANDATORY TRAINING PROGRAM PROVIDED BY THE ORGANIZATION, COVERING ESSENTIAL ASPECTS OF RUNNING A TUCKSHOP.

## **5. WAITING PERIOD**

THE MEMBER ACKNOWLEDGES THAT THERE WILL BE A WAITING PERIOD BEFORE STOCK IS AWARDED, WHICH WILL INCLUDE THE DURATION NEEDED FOR TRAINING AND THE POSITION THE MEMBER HAS IN THE WAITING LIST. WAITING PERIOD IS EXPECTED TO BE 2 - 3 MONTHS.

## **6. STOCK PROVISION**

UPON SUCCESSFUL COMPLETION OF THE DUE DILIGENCE AND TRAINING, THE MEMBER WILL RECEIVE STOCK VALUED AT R10000. THE SPECIFICS OF THE STOCK, INCLUDING QUANTITY AND TYPE, WILL BE DETAILED DURING THE DUE DILIGENCE AND TRAINING PROCESS.

## **7. PROCUREMENT OF STOCK**

THE MEMBER AGREES THAT ALL PROCUREMENT OF STOCK FOR RESTOCKING THEIR TUCKSHOP MUST BE DONE EXCLUSIVELY THROUGH THE ORGANIZATION WITHIN 4 - 6 WEEKS AFTER RECEIVING THE START-UP STOCK OF R10 000. THE ORGANIZATION WILL SUPPLY STOCK FROM ITS WAREHOUSES LOCATED IN EACH PROVINCE AND DISTRIBUTION CENTRES IN EACH TOWN.

## **8. INVENTORY MANAGEMENT SYSTEM**

THE ORGANIZATION WILL PROVIDE AN INVENTORY MANAGEMENT SYSTEM ALONGSIDE THE STOCK. THIS SYSTEM IS DESIGNED TO HELP THE MEMBER MANAGE THEIR INVENTORY EFFECTIVELY.

## **9. CASH TILLS**

THE MEMBER WILL RECEIVE CASH TILLS TOGETHER WITH THE STOCK THAT ARE LINKED TO THE ORGANIZATION'S MAIN SYSTEM AT HEAD OFFICE. THE MEMBER AGREES TO USE THESE TILLS FOR ALL TRANSACTIONS RELATED TO THEIR TUCKSHOP.

## **10. MONTHLY CONTRIBUTION**

THE MEMBER AGREES TO PAY A MONTHLY CONTRIBUTION OF R150.00. MEMBERS ABOVE 64 YEARS OLD AGREE TO PAY R190.00. THIS CONTRIBUTION IS TO ENABLE THE MEMBER TO GET ACCESS TO AGCTA SERVICES, ACCESS TO BULK BUYING PLATFORM, ACCESS TO AGCTA MANAGEMENT SYSTEM, AND TO SUPPORT OTHER MEMBERS IN RECEIVING STOCK.

## **11. COMPLIANCE**

THE MEMBER AGREES TO COMPLY WITH ALL TERMS OUTLINED IN THIS AGREEMENT, INCLUDING TIMELY PAYMENT OF MONTHLY CONTRIBUTIONS AND COMPLETION OF ALL REQUIRED TRAINING. THE MEMBER ALSO AGREES TO COMPLY WITH ALL THE RELEVANT REGULATORY BODIES OF THE REPUBLIC OF SOUTH AFRICA.

## **12. USE OF STOCK**

THE STOCK RECEIVED MUST BE USED FOR THE OPERATION OF THE MEMBER'S TUCKSHOP. THE MEMBER AGREES NOT TO SELL OR DISTRIBUTE THE STOCK FOR ANY PURPOSE OTHER THAN ITS INTENDED USE.

## **13. DURATION**

THE DURATION OF THIS CONTRACT SHALL BE FOR A PERIOD OF 60 MONTHS (5 YEARS) STARTING FROM THE DATE THIS CONTRACT WAS SIGNED.

## **14. JOINT VENTURE**

THIS CONTRACT AUTOMATICALLY BINDS THE MEMBER (ENTREPRENEUR) AND AGCTA INTO A JOINT VENTURE AGREEMENT FOR THE MUTUAL BENEFIT OF BOTH PARTIES. A SEPERATE JOINT VENTURE AGREEMENT WILL BE SIGNED BY BOTH PARTIES.

## **15. DEFAULT**

IF THE MEMBER FAILS TO MAKE THE MONTHLY CONTRIBUTION FOR THREE CONSECUTIVE MONTHS, THE ORGANIZATION RESERVES THE RIGHT TO RECLAIM THE STOCK PROVIDED AND/OR TERMINATE THIS AGREEMENT. THE MEMBER WILL THEREFORE BE LIABLE TO REPAY BACK THE STOCK, IF THE MEMBER IS NOT ABLE TO REPAYBACK THE STOCK LEGAL ACTION MAY BE TAKEN AGAINST THE MEMBER.

## **16. TERMINATION**

THIS AGREEMENT MAY BE TERMINATED BY EITHER PARTY WITH A ONE MONTH PERIOD WRITTEN NOTICE IF THERE IS A BREACH OF TERMS, FAILURE TO PAY CONTRIBUTIONS, OR ANY OTHER REASONABLE CAUSE. THIS COUNTRACT WILL BE TERMINATED SHOULD THE ENTREPRENEUR BE FOUND WITH ILLEGEL, EXPIRED, AND STOLEN PRODUCTS/GOODS/ ITEMS. THE CONTRACT WILL BE TERMINATED SHOULD THE ENTREPRENEUR BE FOUND IN THE POSSESSION OF DRUGS.

## **17. GOVERNING LAW**

THIS AGREEMENT SHALL BE GOVERNED BY THE LAWS OF SOUTH AFRICA.
